We collect personal data that you provide in the following circumstances:

#### 5. Purposes of Processing and Retention Periods

Purpose: Delivery of services or products

Data Types: Contact information, company details, service-specific information

Lawful Basis: Contract performance

**Retention Period**: We will delete your personal data promptly upon your request to stop services or delete your account with us, in accordance with applicable data protection laws.

Purpose: Communication

**Data Types**: Contact information **Lawful Basis**: Legitimate interests

**Retention Period**: We will delete your personal data promptly upon your request to opt out of communications with us, in accordance with applicable data protection laws.

Purpose: Billing

**Data Types**: Financial information

**Lawful Basis**: Contract performance, Legal obligation

**Retention Period**: We will retain billing data for a period of 6 years in compliance with anti-money laundering, taxation regulations, and other applicable legal obligations.

**Purpose**: Personalised product recommendation

**Data Types**: Health data

Lawful Basis: Explicit consent

**Retention Period**: We will delete your personal data promptly upon your request to stop services or delete your account with us, in accordance with applicable data protection laws.

**Purpose**: Responding to enquiries

**Data Types**: Contact information, enquiry details

Lawful Basis: Consent, Legitimate interests

Retention Period: We will delete all dormant enquiries within two years.

# 6. Legal Bases for Processing

We process your personal data on the following legal bases:

Legal obligation (Article 6(1)(c) UK GDPR):

Where processing is necessary for compliance with a legal obligation to which we are

subject.

Legitimate interests (Article 6(1)(f) UK GDPR):

Where processing is necessary for the purposes of the legitimate interests pursued by

us, except where such interests are overridden by your interests or fundamental rights

and freedoms.

Consent (Article 6(1)(a) UK GDPR):

Where you have given consent to the processing of your personal data for one or more

specific purposes.

Explicit Consent (Article 9(2)(a) UK GDPR)

Where you have given explicit consent for us to collect and process special category

data (e.g. health information).

### 7.1 Website usage and Analytics

We use Cabin, a privacy preserving analytics solution to monitor website usage and to improve user experience. Cabin does not collect, log or store IP addresses, or other identifying information. Cabin may collect or infer information about your device, browser and interactions with the website. You can review the data Cabin collects in their documentation.

### 8. International Data Transfers

In some cases, our third-party service providers may be based outside the UK or European Economic Area (EEA). Whenever we transfer your personal data out of the UK or EEA, we ensure a similar degree of protection by using contracts approved for use in the UK and the EU.
